- 8. Appointment of Auditor for the forthcoming year. The Committee propose that we continue to ask Atla Group to be our Auditors for the forthcoming year.
- 9. Other business
 - Solo classes: we propose no changes from 2024
 - Fees:

- No change to rider's membership: £40
- Increase in Supporter's membership to £25
 Still good value as it gives free spectator access to all test and race days
- No increase in race entry fees: £129 for first event, £30 for 2nd event and (new for 2025) only £10 for 3rd and subsequent events
- Foreign (inc UK) riders' entry fees: increase from 50% to 75% of full fee
- Previous winners of Novice & Clubman championship will not be allowed to enter class in 2025
- Sidecar entries: propose shortened 4 event season: March, April (for TT Mountain licence signatures) and the July 2-day event
- As in 2024, signatures for TT Mountain Course licence can be gained right up to the start of TT practice. ARA has three events before TT 2025
- Track prep / Jason's set up team help needed!
- Trophies for meetings: club is investigating 1st, 2nd & 3rd trophies for 2nd race of the day for each class
