- 3. Chairman's report: Linda Alton-Heath
 - 2025 has been a year of progress, resilience, and ambition
 - Jurby Day was a standout success clear skies, fantastic racing, and a brilliant atmosphere that not only showcased our passion but also strengthened our finances
 - The Celtic Match Races returned, with key ARA involvement
 - Current and former ARA riders had a great seasons on the roads and world stage:
 - Ryan & Callum Crowe 2 TT wins, 2 S100 wins, club championship they hold every sidecar title
 on the Isle of Man!
 - Jamie Williams had two wins at the MGP, Michael Evans joined the 130mph club, Marcus Simpson raised his fastest lap to 127mph before heading to Macau. Grant Thomson impressed everywhere, winning Pre-TT Classic races, being our fastest newcomer at MGP, and scoring strong S100 results. Mickey Evans had top 10 finishes at the NW200 and Macau, while Jamie Cringle debuted at the NW200 and rode for Bathams at TT.
 - Six ARA newcomers finished races at MGP, a huge achievement. And let's not forget Sean Crone, who at just 16 won our Lightweight Championship and progressed to BSB Superteens with the Rokit Team
 - Every race class had a title sponsor this year, and demand was so high that the Steam Packet stepped up
 to sponsor our race school. Thanks to Lee Bartram for driving our sponsorship and social media presence.
 We've built on our partnership with Manx Radio, contributing previews before every meeting and
 advertising events. Carol secured lottery funding that covered 80% of the cost of a £14,000 radio system
 upgrade, a huge step forward for safety and efficiency at our meetings.
 - This year, we also joined NORA92 under our trading name Jurby Event Management, giving us flexibility to run car and bike events under a recognized governing body.
 - Despite repeated requests, we still haven't had our 3rd track approved by the ACU; we are continuing to push for this.
 - The management of Jurby is out for tender with the DoI, and ARA are preparing a bid. This is a great
 opportunity for the club, and if we win it will allow the club to invest in power, tarmac, proper
 infrastructure, a clubhouse—the kind of facilities that will elevate ARA to the next level.
 - The circuit has been inspected by the ACU, and approved for racing in 2026 subject to completing some work, which Jason Walker is managing.
 - As always, many thanks to the volunteers committee, marshals, medics, tech team and timekeepers

8. Appointment of Auditor/Accountant for the forthcoming year

Club Secretary Neal Champion explained that the Atla Group were no longer a good match to be the club's accountants for the future, being too large and expensive now. The Committee thanks Brown Craine, which became Atla, for their past good work with the club, and propose that we move to Ealish Baxter of Cruinn Accounting to prepare our accounts for the 2025 financial year just ended. Ealish will also move our financial record keeping onto a professional accounting package (Xero).

We propose to change the wording of the role from 'Auditor' to 'Auditor or Accountant'. We need an accountant to prepare our accounts ensure they comply with the Isle of Man Companies Act. We do not have a statutory requirement for an auditor to carry our a formal audit, which is a more significant assurance exercise.

This change also requires a change to Article 48 in the club's Articles of Association, which uses the word 'auditor':

"48. An auditor shall be appointed to and their duties regulated in accordance with the Acts or any statutory modification thereof for the time being in force"

The word 'auditor' will be substituted with 'accountant or auditor'

9. Any other business

- Fees
 - o No change to Rider's membership (£40) or Supporter's membership (£25) for 2026
 - Entry fees will once again be pegged, at £129 for first event and £30 for second and subsequent events
 - Non-Manx riders will continue to benefit from a 25% discount on entry fees
- Sidecars

The committee proposed running a four event sidecar championship as in 2025, with race days in March, April and July (2 day). The meeting discussed this, and agreed to include sidecar races in our September championship round, and have flexibility to include a sidecar non-championship race in our May event, if needed by Manx sidecar crews in order to qualify for their TT Mountain Licence.

- The club will continue to provide trophies for the first 3 in each class for the second race only.
- Classes
 - The Singles class doesn't have enough entries to justify a championship, and so will not run in
 2026. Riders with a single cylinder machine can still race it in the Singles, Twins & Triples event
 - The Supertwin class has weak entries. With the addition of the Sportbike class in MGP & TT for 2026, we plan to do the same, with the hope of making this a viable class again. Jo Wariner (chief technical official) informed the meeting that she doesn't yet have the information required to be able to confirm that she could police Sportbike eligibility, but hoped that this would be available when the 2026 TT regulations are published
 - The club proposes changes to the Novice & Clubman class, due to safety concerns around the significant spread of speeds and skills of the riders and machines entered. A full discussion was





held, and the meeting agreed to changes to split the entry into two qualifying sessions and two separate races, subject to numbers. Full details will be specified in the Supplementary Regulations.

• Grids for the 2nd race of the day
A proposal from the floor to set the grid for the 2nd event based on each rider's fastest lap from the 1st event was discussed and agreed. The feasibility of this to be confirmed by the timekeepers.

All the above items of business were approved by the meeting
